**Louisiana Derby Early Bird**

**\$750,000 Guaranteed - Grade II**

To Be Run: Saturday, March 27, 2010

Early Bird Nomination Fee of \$500 due by Monday, December 14, 2009, which includes nomination fee for first two races of Louisiana Derby Series: \$100,000 guaranteed Lecomte Stakes (Grade III) on January 23, 2010, and \$300,000 guaranteed Risen Star Stakes (Grade III) on February 20, 2010. For Three-Year-Olds (Foals of 2007) by subscription of \$500 (early bird which also nominates said horse to Lecomte Stakes and Risen Star Stakes). Final nomination for Louisiana Derby closes Saturday, March 13, 2010, by subscription of \$750; \$3,700 to pass the entry box and \$3,700 to start. Supplementary nominations of \$25,000 (includes entry and starting fees) may be made at time of entry. ANY HORSE THAT STARTS IN BOTH THE RISEN STAR AND THE LOUISIANA DERBY AND FINISHES FIRST, SECOND OR THIRD IN EITHER OF THE TWO RACES (PROVIDED THAT SUCH HORSE MEETS ALL APPLICABLE REQUIREMENTS FOR ENTRY AND ENTERS THE KENTUCKY DERBY) WILL HAVE ITS STARTING FEE WAIVED FOR THE KENTUCKY DERBY. The guaranteed purse will be divided as follows: 60% to first, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to sixth through ninth. Weight: Colts and geldings, 122 lbs.; fillies, 117 lbs. This race will be limited to 14 starters. Preference will be given in the following manner: first preference to graded or group winners in order (I, II, III), then highest career earnings (non-restricted), then total career earnings. Second choice high earners of a same owner entry receive no consideration over a single entry.
