AN OVERNIGHT STAKES FOR THREE YEAR OLDS AND UPWARD ACCREDITED LOUISIANA BRED Free nomination by Saturday, November 3. \$250 to enter, \$250 additional to start. Supplemental nominations of \$1,000 will be accepted at time of entry which shall include all fees. \$50,000 Guaranteed, after payment of 1% to all owners of horses finishing sixth through ninth, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Any unpaid purse monies shall revert to the winner. Weight: Three Year Old - 121 lbs, Older - 124 lbs. Non-winners of \$35,000 at a mile or over on the turf since August 16 allowed 2 lbs, \$25,000 at a mile or over on the turf since July 16 allowed 4 lbs, \$20,000 of such a race since then allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. The maximum field size for The Mr. Sulu Overnight Stakes will be determined by rail setting. Preference will be given to horses that accumulated the highest lifetime earnings on the turf. Any horse excluded from running because of the aforementioned preference will be refunded the entry fee and supplementary nomination fee if applicable. A trophy will be presented to the winning owner.
