Weights: Tuesday, November 13. Starters to be named through the entry box by the usual time of closing. The Thanksgiving Handicap will be limited to fourteen (14) starters. High weights on the scale will be preferred. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee or supplementary nomination fee if applicable. A trophy will be presented to the winning owner.
