

TOM BENSON MEMORIAL OVERNIGHT STAKES

\$50,000 Guaranteed

AN OVERNIGHT STAKES FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD ACCREDITED LOUISIANA BRED Free nomination by Saturday, November 3. \$250 to enter, \$250 additional to start. Supplemental nominations of \$1,000 will be accepted at time of entry which shall include all fees. \$50,000 Guaranteed, after payment of 1% to all owners of horses finishing sixth through ninth, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Any unpaid purse monies will revert to the winner. Weight: Three Year Olds - 121 lbs, Older - 124 lbs. Non-winners of \$35,000 at a mile or over on the turf since August 15 allowed 2 lbs, \$25,000 at a mile or over on the turf since July 15 allowed 4 lbs, \$20,000 of such a race since then allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. Field size for the Tom Benson Memorial Overnight Stakes will be determined by rail setting. Preference will be given to horses that have accumulated the highest lifetime earnings on the turf. Any horse excluded from the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. A trophy will be presented to the winning owner.
