Weights: Friday, March 15. Starters to be named through the entry box by the usual time of closing. The maximum field size for the Muniz Memorial Handicap will be determined by rail setting. High weights on the scale will be preferred. A trophy will be presented to the winning owner. The winner of the 2019 Muniz Memorial Handicap (GII) will be granted an automatic berth (no fees) to the 2019 Old Forester Turf Classic (GI) and the Arlington Million (GI).
