Supplemental nominations of \$2,500 will be accepted at time of entry which shall include all fees. \$125,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to finishers sixth through ninth. Any unpaid purse monies will revert to the winner. Weight: Three Year Old - 122, Older - 124. Non-winners of \$65,000 since September 26, allowed 2 lbs. \$55,000 since August 26, allowed 4 lbs. \$45,000 since then allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. The Thanksgiving Classic will be limited to fourteen (14) starters. Preference will be given in the following manner: graded or group winner in order (I, II, III), then highest lifetime earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee or supplementary nomination fee if applicable. A trophy will be presented to the winning owner.
