**FOR THREE YEAR OLDS** Early Bird Nomination Fee of \$400 due by Saturday, December 26, 2020, which includes nomination fee for The Lecomte Stakes (GIII) and The Risen Star Stakes (GI). Final nomination for The Louisiana Derby closes Saturday, March 6, 2021 by subscription of \$1,000, \$5,000 to enter, \$5,000 additional to start. Supplemental nominations of \$25,000 will be accepted at time of entry which shall include all fees. \$1,000,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to finishers sixth through ninth. Weights: Colts and Geldings - 122 lbs; Fillies - 117 lbs. Starters to be named through the entry box by the usual time of closing. The Louisiana Derby will be limited to fourteen (14) starters. Preference will be given in the following manner: First preference to graded or group winners in order (I,II,III), then to horses that have accumulated the highest lifetime earnings. Any horse excluded from running because of the aforementioned preference will be refunded the entry fee or supplementary nomination fee if applicable. For Three Year Olds entered under International Medication Protocol. Horses nominated or entered to compete shall not be eligible to receive furosemide less than twenty-four (24) hours prior to post time for this race. A trophy will be presented to the winning owner. Certain finishing positions in this race will earn points to qualify for the 2021 Kentucky Derby, pursuant to the official rules for the Road to the Kentucky Derby published by Churchill Downs Incorporated. Points will be earned in the following manner: 100 to the winner, 40 to second, 20 to third and 10 to fourth.
