\$300,000 Guaranteed
(Grade II)**

FOUR YEAR OLDS AND UPWARD By subscription of \$300 by Saturday, March 6, \$1,500 to enter, \$1,500 additional to start. Supplemental nominations of \$8,000 will be accepted at time of entry which shall include all fees. \$300,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to finishers sixth through ninth. Weight: 124. Non-winners of a Grade I or Grade II sweepstakes at a mile or over on the turf since September 20 allowed 2 lbs. Non-winners of a sweepstakes at a mile or over on the turf since December 20 allowed 4 lbs. Non-winners of \$55,000 of such a race since then allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. The maximum field size for the Muniz Memorial Classic will be determined by rail setting. Preference will be given in the following manner: graded or group winners in order (I, II, III), then highest lifetime earnings on the turf. A trophy will be presented to the winning owner. The winner of the 2021 Muniz Memorial Classic (GI) will be granted an automatic berth (no fees) to the 2021 Old Forester Bourbon Turf Classic (GI) and the Mister D. Stakes (GI).
