FOR FILLIES THREE YEARS OLD By subscription of \$400 by Saturday, March 6; \$2,000 to enter, \$2,000 additional to start. Supplemental nominations of \$10,000 will be accepted at time of entry which shall include all fees. \$400,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to finishers sixth through ninth. Weight: 122 lbs. Starters to be named through the entry box by the usual time of closing. The Fair Grounds Oaks will be limited to fourteen (14) starters. Preference will be given in the following manner: First preference to graded or group winners in order (I,II,III), then to horses that have accumulated the highest lifetime earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee or supplementary nomination fee if applicable. A trophy will be presented to the winning owner. For Three Year Old Fillies under the International Medication Protocol. Horses nominated or entered to compete shall not be eligible to receive Furosemide less than twenty-four (24) hours prior to post time. Certain finishing positions in this race will earn points to qualify for the 2021 Kentucky Oaks, pursuant to the official rules for the Road to the Kentucky Oaks published by Churchill Downs Incorporated. Points will be earned in the following manner: 100 to the winner, 40 to second, 20 to third and 10 to fourth.
