FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD By subscription of \$150 by Saturday, March 6. \$750 to enter, \$750 additional to start. Supplemental nominations of \$2,500 will be accepted at time of entry which shall include all fees. \$150,000 Guaranteed, 60% to the winner, 20% to second, 10% to third, 4% to fourth and 2% to fifth and 1% to finishers sixth through ninth. Weight: 124 lbs. Non-winners of a graded sweepstakes at a mile or over on the turf since September 20 allowed 2 lbs, Non-winners of a sweepstakes at a mile or over on the turf since December 20 allowed 4 lbs, Non-winners of \$55,000 of such a race since then allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. The maximum field size for the Tom Benson Memorial Stakes will be determined by rail setting. Preference will be given in the following manner: graded or group winners in order (I, II, III), then to horses that have accumulated the highest lifetime earnings on the turf. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. A trophy will be presented to the winning owner.
