# THE MAGIC CITY CLASSIC (ALABAMA BRED)

11th Running

**\$50,000 Guaranteed**

**To Be Run: Friday, December 10, 2021**

**FOR THREE YEARS OLD AND UPWARD, REGISTERED ALABAMA BREDS.** By subscription of \$50 by Wednesday, November 17. \$250 to enter, \$250 additional to start. Weights: Three Year Old - 118 lbs; Older - 123 lbs. Non-winners of a sweepstakes in 2021 allowed 2 lbs, of a race other than maiden or claiming since October 10 allowed 4 lbs, such a race in 2021 allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. This race is restricted to horses bred in the State of Alabama and are registered with the Birmingham Racing Commission Breeding and Development Fund. Nomination, entry and starting fees must be deposited with the horseman's bookkeeper prior to the running of the race. All nomination, entry and starting fees will be paid to the breeders of those horses finishing first, second and third, with 50% going to the breeder of the winner, 30% to second, and 20% to third. The \$50,000 purse will be divided as follows: 55% to the owner of the winner, 20% to second, 11% to third, 5% to fourth, 3% to fifth and 2% to sixth, seventh and eighth. In the event of less than eight (8) starters, those percentages will be paid to the winner. The Magic City Classic will be limited to twelve (12) starters. In the event that more than twelve pass the entry box, preference will be given to winners first and secondly to horses that have accumulated the highest earnings in 2021. The rules and regulations adopted by the Louisiana Racing Commission govern all races conducted under the auspices of the Fair Grounds Race Course & Slots. Should an insufficient number of horses pass the entry box, this race may be cancelled with nomination and entry fees returned.
