FOR FILLIES AND MARES THREE YEAR OLD AND UPWARD Free nomination by Saturday, November 13. \$375 to enter; \$375 additional to start. Supplemental nominations of \$1,500 will be accepted at time of entry which shall include all fees. \$75,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth and 2% to fifth and 1% to finishers sixth through ninth. Any unpaid purse monies will revert to the winner. Weights: Three Year Old - 122 lbs. Older - 124 lbs. Non-winners of a Stakes race at a mile or over on the turf in 2021, allowed 2 lbs. \$65,000 at a mile or over on the turf since October 25 allowed 4 lbs. \$55,000 at a mile or over on the turf since then allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. The maximum number of starters for the Joseph R. Peluso Memorial Stakes will be determined by rail setting. Preference will be given in the following manner: graded or group winners in order (I, II, III), then highest lifetime earnings on the turf. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee or supplementary nomination fee if applicable. A trophy will be presented to the winning owner.
